ELECTORAL GUIDELINES

2026 – 2030

INTRODUCTION:

These Electoral Guidelines will guide the Elections and by-elections of USSSA at District/City, Zonal and National level for the period 2026 – 2030.

GENERIC ELECTION GUIDELINES

- 1) Candidates for all positions must be professional and registered teachers with a secondary school teacher qualification
- 2) To contest, one must be a teacher in a Ministry of Education and Sports (MoES) recognized Secondary school located geographically within the area he / she intends to represent
- 3) For the position of Chairperson and Treasurer at the District/City and Zonal Executive, the candidate must be a substantive Headteacher in a MoES recognized secondary school or Director of a secondary school who must be a professional and registered teacher with a minimum of a degree in education (Graduate Teacher / Education Officer). The Headteachers in private schools must possess a minimum of a degree and 7 years teaching experience to qualify to contest.
- 4) For the position of Secretary and Assistant Secretary the candidates must be classroom teachers
- 5) The Candidates for the position of Secretary for Women must be female
- 6) The ASSHU representative must be an executive member of ASSHU at the same level or above (District, Zone/Region, National)
- 7) Delegates to the next level assembly will be voted for by the executive from among themselves on the day of their election
- 8) The candidate, nominator and seconder must be from different schools for the District Assembly, different districts for the Zonal Assembly and different zones for the National Assembly



- 9) Positions that do not attract candidates by closure of nomination will be filled on the floor on the day of election. Even then all the requirements for the positions must be fulfilled
- 10) Voting will be by secret ballot at all levels
- 11) One need not be a delegate to qualify to contest for a position at any level.
- 12) A candidate can be nominated and voted for in absentia.
- 13) The election road map to be circulated by Returning Officer
- 14) The 2022 nomination fees are to be maintained at all levels for 2026-2030 elections
- 15) Voting by proxy or by letter will not be allowed
- 16) Results will be by simple majority
- 17) No person or entity can nominate more than one person for the same position at the same level.
- 18) Persons in both government and private schools will be categorized under the area of the Government School. This applies to Directors who are on Governments payroll.
- 19) Only persons coming from paid up entities and registered on the USSSA online registration system are eligible to nominate, second, be voted and to vote
- 20) One can only be nominated for one position at a level. The only exception is where a position does not attract any candidates by closure of nomination
- 21) Elections for all positions will only be done during the USSSA organized elective assembly
- 22) Candidates must present evidence of documents and financial clearance before being declared nominated. This can even be called for after the declaration.



- 23) There will be a maximum of 2 delegates from each school for the district assembly, 5 delegates from each district to the zonal assembly and 5 delegates from each zone for national assembly.
- 24) The school from which the delegate comes to the District Assembly must have participated in USSSA Activities and registered on the USSSA Online registration system for the last 2 years (2025 – 2026)
- 25) Each delegate will have only 1 vote at all levels
- 26) The nominations to the Zonal and National Executive will be done by the newly Elected Executive 2026
- 27) All election related payments must be made on the specified USSSA account & mobile money number provided.
- 28) Only Districts and Zones with fully elected Executive are cleared to send delegates to the Zonal and National Assembly respectively.
- 29) All delegates to the Zonal and National Assemblies must be executive committee members of the District and zone respectively.
- 30) Nomination forms will be picked from the returning officer or downloaded from various USSSA online platforms.
- 31) In the event of a tie for No. 1, another round of voting will be done for the tying candidates
- a. In a second round, the candidate with the highest number of votes will be elected.
 - b. In the second round, if the candidates still receive the same number of votes, there will be a third round.
 - c. In the third round, if the candidates receive the same number of votes the decision will be made by lot taken by the candidates and the result declared by the Electoral Committee publicly.
 - d. a ballot will be considered as invalid if it is marked in any other way other than as instructed or not marked.



32) Each delegate must tick only one candidate on the ballot except the case where they are clearly instructed to tick more than one name.





- ii. Must have served in an elective position on USSSA National Executive Committee for at least one full elective term or served as a Member of ASSHU National Standing Committee for at least 1 elective term.



b) 1st Vice President


- i. Must be a substantive Head teacher of a recognized Government Secondary School or a Director of a private Secondary School recognized by the Ministry of Education and Sports who holds professional qualifications of a secondary school teacher at Educational Officer Level/ Graduate Level.
- ii. Must have served on in an elective position on USSSA National Executive Committee for at least one full elective term or served as a Member of ASSHU National Standing Committee for at least 1 elective term
- iii. For affirmative action if the president is from a government school the 1st vice president must be from a private school and vice versa

c) 2nd Vice President

- i. Must be a substantive Head teacher of a recognized Government Secondary School or a Director of a private Secondary School recognized by the Ministry of Education and Sports who holds professional qualifications of a secondary school teacher at Educational Officer Level/ Graduate Level.
- ii. Must have served in an elective position on USSSA National Executive Committee for at least one full elective term or served as a Member of ASSHU National Standing Committee for at least 1 elective term

d) 3rd Vice President

- i. Must have served on the National Executive Committee for at least one term or must have served as Chairperson of a Zonal Association for at least one term.
- ii. Must have served in an elective position on USSSA National Executive Committee for at least one full elective term or served as a Member of ASSHU National Executive Committee for at least 1 elective term or served as chairperson or secretary of a USSSA Zonal Association for at least 1 elective term.
- iii. For affirmative action, if the Holders of the above 3 positions are of the same gender, then the 3rd Vice President will be of the opposite gender.



e) Secretary for Women Affairs

- i. Must be a female
- ii. Must have been on USSSA National Executive Committee for at least one elective term.

f) Regional representatives:

- i. Must be from a school within that region



- i. The nomination forms may be picked from the Returning Officer, or down loaded from the various USSSA online platforms.
- ii. The candidate, nominator and seconder must be coming from different Zones
- iii. The nomination form must be signed by the Chairperson or Secretary of the nominating and seconding Zones
- iv. Only persons coming from paid up Zones are eligible for nomination and voting
- v. One need not be a delegate to be nominated for any of the positions at national level, but must possess the requirements for the position.
- vi. Upon closure of nomination, if a position does not attract any candidate, such a position will be filled by nomination on the Election Day
